PRODUCT DESCRIPTION: *ProClean Tile Cleaner & Remover* is a ready for use, concentrated acid based cleaner that is suitable for cleaning and removing cement mortar, efflorescence, lime wash, oil and general stains from terracotta tiles, ceramic (glazed) tiles, slate, brick, concrete, tile grout, pool mosaics and similar surfaces.

INTENDED USES: *ProClean Tile Cleaner & Remover* is ideal for cleaning cement mortar, brick work, stone facades, pool mosaics, clay copings, slate, concrete and rejuvenating old tile grout. *ProClean Tile Cleaner & Remover* may be used on terracotta tile, ceramic (glazed) tiles, quarry tiles and slate. Removes cement from building equipment and earth stains from masonry surfaces.

FEATURES: *ProClean Tile Cleaner & Remover* activates with stubborn dirt, stains and blemishes to ensure an effective method of cleaning. It is non-flammable and economical (as in most instances a dilution with water is necessary).

APPLICATION DETAILS:

• THINNING	May be diluted with up to 15 parts water.
• CLEANING	Water.
• SUBSTRATE	Cement mortar, brick work, stone facades, pool mosaics, clay copings, slate, concrete, tile grout, terracotta tiles, ceramic (glazed) tiles, quarry tiles and slate Before applying, carry out a trial test patch to ensure the suitability of the substrate and the correct concentration required.

PREPARATION:

- **All surfaces** – remove all furniture, metal objects, brass, copper, magnesium, zinc, stainless steel, anodized aluminium and chromed items from the area to be cleaned. Avoid use on acrylic or polyester sanitary ware. Avoid contact with fabrics.
- Use only in well ventilated area.
- Before applying, carry out a trial test patch to ensure the suitability of the substrate and the correct concentration required.
- Dilute with water (up to 15 parts water) as required, for the specific cleaning application.
- When diluting with water, add *ProClean Tile Cleaner & Remover* to water and not vice versa to prevent accidental splashing.

APPLICATION:

- **Dilution:** light cleaning (10-15 parts water), medium duty cleaning (5-10 parts water), heavy duty cleaning (0-5 parts water).
- General cleaning – apply a liberal coat (either neat or diluted as required) and allow to activate for 5 minutes.
- Once activated, scrub area vigorously with a stiff brush, broom, sponge or cloth as required, until frothing is complete.
- It is recommended that small areas be cleaned at a time to avoid damage to the surface being cleaned.
- Once surface is clean, rinse well with water.
- Some areas may require further treatment. Repeat cleaning and scrubbing process in these areas.
- Rinse with clean water and allow to dry.
- If surface is to be painted, clean off any acid residues with *ProLong Sugar Soap*, and rinse off with fresh water.

STORAGE AND PACKAGING:

- Store away from direct sun, heat and severe cold.
- Keep containers tightly closed.
- Packaging: 1lt & 5lt.
- Shelf life. 24 months from date of manufacture when correctly stored and unopened.

- Waste disposal – do not empty into drains or water courses.

- Store in upright position. Ensure container and lid in good condition.
- Keep away from children.
- Open and use in well ventilated area.
- The use of personal protective equipment is recommended, e.g. rubber gloves and goggles.
- Keep away from food, drink and animal feed.
- Take care to avoid contact with eyes. In case of contact, rinse eyes with clean water and seek medical attention.
- If contact with skin should occur, wash well with soap and water.
